### Importing Shelf-stable Foods in Japan

**Shelf Stable Food Import Applications** are approved by the Japan Ministry of Health Labor and Welfare (MHLW). Every shipment requires an application and pre-approval from MHLW prior to shipping.

**MHLW** is the sole determining agency for Shelf Stable Food Import Applications. Each application is reviewed and approved by the agency.

MHLW requires only one manufacturer per import application. All products listed on the application must be shipped.

#### To repeat your shipment:

- 1. Ship the exact products listed on the 1st application and shipment. You may only change the destination and quantity of the products shipped. This is called Replicated Application only IOR Fees charged.
- 2. If you remove/add products to the shipment or change the manufacturer's information, you will need to undergo a NEW Import Application. An application fee will be charged.

#### Process

- MHLW Pre-Notification MHLW will review the Pre-Notification and determine what additional informational requirements will be needed. It will take about 15-25 days.
- 2. **MHLW Lab Testing** COVUE will require the testing of all regulated products. Send us the product sample and COVUE will do the testing.
- 3. Product Labeling Your product requires a Japan Food Product Label.
- 4. Shipping Invoice Prepare your authorized COVUE shipping invoice from your COVUEIOR account.
- 5. Final MHLW Application COVUE will consolidate and prepare the documents and submit them to MHLW. MHLW will review the final application and notify COVUE of approval.

### **Related Terms**

**IOR Registration Fee** – This is a one-time fee with no expiration and covers all types of products under COVUE

**Product Liability Insurance** - Seller will maintain at Seller expense commercial general, umbrella, or liability insurance per occurrence and in aggregate covering liabilities caused by or occurring in conjunction with the operation of Seller business, including products/completed operations and bodily injury, with policy naming CJ and its assignees as additional insureds.

**Product labeling** - All products sold in Japan require Japan Product Labeling compliance.

Shipping Invoice - Only COVUE Authorized Shipping Invoice can be used.
Rules for Foreign Online Sellers - Japan Customs has simplified the process for Foreign Online Sellers by requiring Foreign Online Sellers to Declare Import Value = Online Selling Price.

**MHLW** is the sole determining agency for Shelf Stable Food Import Applications.

**MHLW Lab Testing** - To mitigate (lower) the risk of recall or potential harm to Japanese buyers of COVUE IOR clients. COVUE will require the testing of all regulated products. Product testing will be controlled by COVUE.

#### How it works?

- Client will send product samples (minimum of 2 pcs per product) to COVUE Facility for inspection
- COVUE will arrange lab testing to MHLW
- COVUE Compliance team will notify client with the result and proceed with the application process
